Liquidators' First Report

CEA Trading Limited (In Liquidation & In Receivership)

1. Appointment

We advise that Jeffrey Philip Meltzer and Arron Leslie Heath of Meltzer Mason Heath were appointed joint and several Liquidators of the above company on 3 December 2009 by resolution of creditors passed at the Watershed Meeting.

Arron Heath and Jeff Meltzer are Chartered Accountants and full time Insolvency Practitioners. On 28 April 2009 they were appointed Voluntary Administrators of the company. Prior to their appointment as Voluntary Administrators Mr Meltzer and Mr Heath had not previously acted in any capacity for the company or the officers and shareholders of the company.

3. Events Leading to Appointment

On 28 April 2009 Mr Heath and Mr Meltzer were appointed Voluntary Administrators of the company. Shortly after the Administrators' appointment, on the same day, Receivers and Managers were appointed over the company's assets and undertakings. Due partly to the time of the appointment, prior to the winter season, trading issues relating to the venues and the sales process likely to be undertaken by the Receivers, an extension of the time in which to hold the Administration Watershed Meeting was sought and granted. The Administrators formed the view that no Deed of Company



Arrangement should be proposed and that it was appropriate for the company to be placed in liquidation. Accordingly, at the Watershed Meeting held on 3 December 2009, the creditors agreed that the company should be placed into liquidation and Mr Meltzer and Mr Heath were appointed Liquidators.

4. Statement of Affairs

The Liquidators have prepared an Estimated Statement of Affairs being the assets and liabilities of the company at the date of liquidation. We attach a copy.

5. Proposals for Conducting the Liquidation

5.1 Realisation of Assets

There are no assets available for realisation by the Liquidators.

5.2 Examination of Books and Records

Based on the Administrators' report the Liquidators do not intend to examine the company's available books and records or to conduct a brief review of the company's affairs.

5.3 Knowledge of Information Relevant to the Liquidation

Should creditors and other parties possess any information that may be relevant to the liquidation, or may lead to realisations for the benefit of creditors, please advise the Liquidators in writing and provide them with copies of supporting documents.

6. List of Creditors

A list of all known creditors has been compiled by the Liquidators. We attach a copy.

7. Creditors Claim Form

Creditors should complete and return the enclosed Creditor's claim form by 29 January 2010. Creditors who do not make a claim within the period may be excluded from any distribution that may be made.

8. Retention of Title Claims/Security Interests

All retention of title claims/security interests should have been notified previously to the Receivers.

9. Initial Creditors Meeting

As the Administration Watershed Meeting has been held and it is unlikely there will be a distribution to creditors, pursuant to s245 of the Companies Act 1993 the Liquidators

propose to dispense with the meeting of creditors to consider whether to appoint different Liquidators, and to consider the views of creditors.

Accordingly a meeting of creditors will not be called unless a creditor gives notice to the Liquidators within 10 working days after receiving this notice, requiring a meeting to be called.

10. Liquidation Committee

At any time during the liquidation, any creditor may in writing, request the Liquidators to call a meeting of creditors to consider whether a Liquidation Committee should be appointed, and if so, to choose the members of the Committee.

A Liquidation Committee has certain powers set out in s315 of the Companies Act 1993, including to assist the Liquidators as appropriate in the conduct of the liquidation.

11. Estimated Date of Completion of Liquidation

It is not practicable to estimate the date of completion of the liquidation at this stage.
