#### Property Disposed of Since Previous Report

No property has been sold since the last report as all assets were sold with the business. Since the sale the Receivers have been dealing with cost apportionment, warranty issues and debt collection.

#### Amount Owing to the Debenture Holder

Allowing for costs and accruing interest the total sum due to the secured creditor was in the region of \$320,000 as at the date of appointment.


