3 Events Leading to Appointment

We are advised that the company's business and assets were sold on 5 August 2010. On 10 August 2010 Messrs Stiassny and Gibson of KordaMentha were appointed Receivers and Managers of the Company.

4 Statement of Affairs

The Liquidators have not prepared an Estimated Statement of Affairs at this stage. At the time of writing this report only limited information is available to the Liquidators. The Receivers should issue their first report in October. However, based on discussions with the Receivers it is clear that there will be a shortfall to the secured creditor and as a consequence no funds will be available to unsecured creditors.

As it is unlikely there will be a distribution to creditors, pursuant to s245 of the Companies Act 1993 the Liquidators propose to dispense with the meeting of creditors.

Accordingly a meeting of creditors will not be called unless a creditor gives written notice to the Liquidators within 10 working days after receiving this notice, requiring a meeting to be called.

9 **Liquidation Committee**

At any time during the liquidation, any creditor may in writing, request the Liquidators to call a meeting of creditors to consider whether a Liquidation Committee should be appointed, and if so, to choose the members of the Committee.

A Liquidation Committee has certain powers set out in s315 of the Companies Act 1993, including to assist the Liquidators as appropriate in the conduct of the liquidation.

10 **Estimated Date of Completion of Liquidation**

It is not practicable to estimate the date of completion of the liquidation at this stage.


